- Texas Election ID Certificate\*
- Texas Personal ID Card\*
- Texas Handgun License\*
- U.S. Citizenship Certificate with Photo
- U.S. Military ID Card with Photo\*
- U.S. Passport\* (Book or Card)

**Do not possess and cannot reasonably obtain one of these approved photo IDs? You can fill out a Reasonable Impediment Declaration form and show a copy or original of one of the following supporting documents:**

- Certified Domestic Birth Certificate or Court Admissible Birth Document
- Current Utility Bill
- Bank Statement
- Government Check
- Paycheck
- Government document with your name and an address including your Voter Registration Certificate

\*For voters aged 18-69, the acceptable form of photo identification may be expired no more than four years. For voters aged 70 or older, the acceptable form of photo identification may be expired for any length of time if the identification is otherwise valid.
